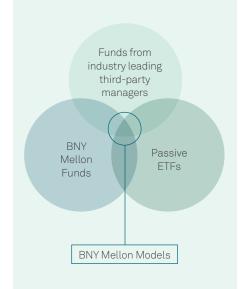

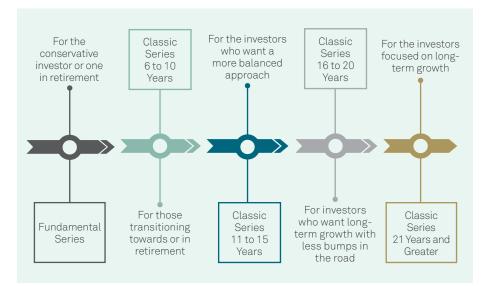
The models provide multi-level diversification incorporating both active and passive styles. Third-party funds are used after rigorous manager due diligence.

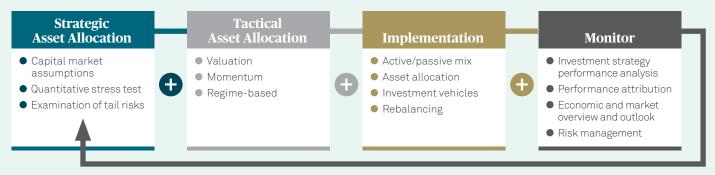
